### What's new this week

- HPPH clinic walk-in opportunities

### Vaccine eligibility

- Individuals ages 12 to 17 are eligible for Pfizer-BioNTech (must be minimum 12 years or older at time of vaccination)
- Individuals age 18 or older are eligible for either Moderna (must be minimum 18 years or older at time of vaccination) or Pfizer-BioNTech.
- Individuals who are 12 or older, and have received their 1st dose of mRNA vaccine, are eligible to book a second dose 28 days after their first dose. At this time only Pfizer can be provided to youth 12-17. Individuals age 18 or older can receive either Moderna or Pfizer as a second dose.

### Vaccine availability

- HPPH does not determine which vaccines are received and allocated for HPPH and Primary Care clinics; Pfizer-BioNTech and Moderna are the COVID-19 vaccines available in the region currently for HPPH mass vaccination clinics.
- Several pharmacies also offer Pfizer or Moderna vaccines. Please visit [COVID-19 Pharmacy Vaccine Locations](#) to learn more.

### Vaccine mixing

- Pfizer and Moderna are interchangeable mRNA COVID-19 vaccines, as endorsed by the Public Health Agency of Canada, the National Advisory Committee on Immunization (NACI), and the Ontario Ministry of Health. This

means that you can receive one vaccine for your first dose and the other vaccine for your second dose.

- Being fully vaccinated is very important. Two doses of vaccine – whether the same product or a mix of two vaccines – provides safe and highly effective protection against the COVID-19 virus and variants, including the highly transmissible Delta variant. It will also count as a completed vaccination series in Ontario.
- HPMVAC strongly encourages everyone to get their vaccine as soon as possible, and to make their second dose a priority once they are eligible. The more people who are fully vaccinated, the less chance of COVID-19 spreading in our communities, especially now the Delta Variant.
- Vaccine supply is not predictable enough at this time to be able to state in advance which HPPH clinics will be Moderna or Pfizer. In order to ensure everyone who booked an appointment will get a vaccine we cannot guarantee one product or the other.
  - All HPPH clinics will be mRNA clinics providing either Moderna or Pfizer.
  - At this time only Pfizer can be provided to youth 12-17. Adults 18+ will be provided with Moderna or Pfizer.
- Individuals can also book an appointment for a vaccination at a participating pharmacy. For a list of local pharmacies and which vaccine they are administering, visit <https://covid-19.ontario.ca/vaccine-locations>.

## Second doses

For individuals who received mRNA vaccine as first dose

- Currently anyone aged 12 or over, who received an mRNA vaccine (Pfizer or Moderna) as their first dose, can book their second dose appointment for a future HPPH clinic at least 28 days after their first dose.
- At this time only Pfizer can be provided to youth 12-17, in keeping with age requirements.
- Vaccination appointments can be made at HPPH clinics or pharmacies.
- Please see AstraZeneca section for further information on second doses for AstraZeneca.
- Please see Appendix A for more information on second-dose eligibility, including those who should be vaccinated as close to product monograph as possible.

For individuals who received AstraZeneca as first dose

- If you received AstraZeneca as your first dose, you should receive your second vaccine (AZ or an mRNA) 8-12 weeks later for optimal immune response. (Note the interval related to mRNA 2<sup>nd</sup> doses may change with the availability of supply). Some people, in consultation with their health care provider, may need to book earlier than 8-12 weeks due to their medical treatment schedule.
- Ontarians who received their first dose of the AstraZeneca COVID-19 vaccine can choose to either receive a second dose of the AstraZeneca vaccine, or an mRNA (Pfizer or Moderna) vaccine for their second dose.
  - Both of these options are safe and provide strong protection against COVID-19. In addition, they will count as a completed vaccine series.
  - Please see Appendix A for more information on second-dose eligibility, including those who should be vaccinated as close to product monograph as possible.

### Opting for AstraZeneca as your second dose:

- Individuals who received their first dose of the AstraZeneca vaccine and who would like their second dose of the AstraZeneca vaccine (provided at the 8 to 12-week interval), can contact the pharmacy where they received their first dose to book an appointment.
- Anyone who went to the April 20 or April 22 Primary Care AstraZeneca clinics in Goderich or Stratford can contact a participating local pharmacy that may have AstraZeneca second doses.

- If you're not able to get to a participating pharmacy and you want AstraZeneca as your second dose, contact your primary care provider.

### Opting for an mRNA vaccine as your second dose:

- Eligible individuals who received their first dose of the AstraZeneca vaccine and would like a second dose of mRNA vaccine (provided at the 8 to 12-week interval) can schedule their second dose appointment at a future HPPH clinic through the HPPH online or telephone booking system.  
OR
- Individuals may also book their second dose appointment at a participating pharmacy where the Pfizer or Moderna vaccines are administered.  
OR
- Visit your primary care provider's website or contact the office for details on how they are administering vaccines.

### How to book a second dose

- HPPH does not book second dose appointments when you get your first dose. You must book your second dose once you are eligible.
- Use the [HPPH second dose calculator](#) to find out when you can receive your second dose.
- Once you know your earliest appointment date, visit the HPPH booking system at [www.hpph.ca/vaccinebooking](http://www.hpph.ca/vaccinebooking) or call 1-833-753-2098 to see available clinics.
  - If your earliest possible second dose date falls within the date range of an upcoming HPPH clinic, please book an appointment. If clinics are not yet available during the time you are due for your second dose, please check back for future clinics.
  - You can also subscribe to the booking webpage to get alerts when new clinics are added.
- If you received your first dose through your primary care provider or at an HPPH community clinic, book at an HPPH community clinic for your second dose OR visit your primary care provider's website or contact the office for details on how they are administering vaccines.
- If you book an appointment before your earliest possible appointment date, and you do not qualify for the earlier dose schedule, you will be turned away at the clinic.
- Remember that Pfizer and Moderna are interchangeable mRNA COVID-19 vaccines. This means that you can receive one vaccine for your first dose and the other vaccine for your second dose.
- Vaccine supply is not predictable enough at this time to be able to state in advance which HPPH clinics will be Moderna or Pfizer. In order to ensure everyone who booked an appointment will get a vaccine we cannot guarantee one product or the other.
  - All HPPH clinics will be mRNA clinics providing either Moderna or Pfizer.
  - At this time only Pfizer can be provided to youth 12-17. Adults 18+ will be provided with Moderna or Pfizer.
- If you want to rebook into a different clinic, you must first cancel your current appointment. However, please remember that we cannot guarantee which vaccine will be available at a future appointment.
- You can also book an appointment for a vaccination at a participating pharmacy. You can see a list of local pharmacies and which vaccine they are administering by visiting <https://covid-19.ontario.ca/vaccine-locations>. ### About HPPH Clinics

- HPPH continues to add vaccine clinics as vaccine supply is confirmed. Please check [www.hpph.ca/vaccinebooking](http://www.hpph.ca/vaccinebooking) for latest availability.
  - Many youth ages 12-17 in Huron-Perth received their first dose between June 14 – June 26. These youths can take advantage of appointments at HPPH clinics the week of July 26-31; however youth can book an appointment, or take advantage of an announced walk-in, during

any available clinic date that is at least 28 days after first dose.

- We thank everyone who are cancelling unneeded appointments as we still need to reduce no-shows. **Please continue to cancel any unneeded appointments.** Go to <http://www.hpph.ca/vaccinebooking> and choose the [Click Here to Cancel your Appointment](#) box or call the booking line at 1-833-753-2098; press 2 (two). Please include your first and last name and the date, time, and location of your scheduled appointment.
- If possible, please bring a completed Consent form found at [www.hpph.ca/vaccinebooking](http://www.hpph.ca/vaccinebooking) under “Before your appointment”.
- We will be posting information for August vaccination opportunities on our website soon.

## Walk-in Opportunities

### HPPH clinics

- In addition to booking appointments, we are now offering walk-in opportunities at clinics for first or second doses.

- Please note:
  - Walk-ins will only be accepted during the specific time given, or until vaccine supply for walk-ins has been used up.
  - If coming for your second dose, it must be at least 28 days since your first mRNA dose.
  - Bring your health card with you, if you have one. Please bring a mask and wear a short-sleeved shirt.
  - Please dress for the weather. You may have to wait outside.
  - If you have a booked appointment for this clinic, you will still receive your vaccine at the scheduled time.
- Please do not come to an HPPH clinic if you have not been given an appointment time OR if a walk-in has not been announced. There will not be vaccine doses available.

### Pharmacies

- Check with your local pharmacy for possible walk-in opportunities. A list of pharmacies that offer COVID-19 vaccinations can be found at [COVID-19 Pharmacy Vaccine Locations](#).

## How to register a vaccination received outside of Ontario or Canada

- If you have received one or more doses of a COVID-19 vaccine outside of the Province of Ontario, you should provide your proof of immunization to Huron Perth Public Health. HPPH will add it to COVaxON, the provincial vaccination system.
- Ensuring vaccination information is up-to-date allows individuals to:
  - Book a second dose appointment (for those who have only received one dose of a two-dose vaccine).
  - Receive an Ontario vaccination receipt which can be used to show immunization status.
  - Share their COVID-19 immunization records with their health care providers and for other uses required by provincial law.
- Having more complete vaccination coverage information also helps the province as it uses vaccination coverage to help inform re-opening plans.
- Easily register vaccinations received outside of Ontario or Canada at [www.hpph.ca/vaccine](http://www.hpph.ca/vaccine) and click the button that says “Submit your **COVID-19 Out-of-Province Dose Documentation**”.

## Information for healthcare providers and pharmacists

- If an individual has received the recommended dose(s) of a COVID-19 vaccine that has not been approved by

Health Canada but is listed for emergency use by the WHO (e.g. Sinopharm, Janssen), this will be considered as a valid dose(s). We do not recommend additional doses at this time. These individuals should submit their documentation to the HPPH online form and we will enter into COVax ON.

## How to get provincial vaccination receipts

- After each dose of the COVID-19 vaccine that you get, you will be able to log into the provincial portal to download and or print an electronic COVID-19 vaccine receipt. The vaccine receipt will be a PDF document.
- You will need the following to log into the provincial portal:
  - A green photo health (OHIP) card (you will need the numbers from the front and back of the card, expired cards will be accepted)
  - Your date of birth
  - Your postal code that is associated with your health card

## Current Vaccination progress

- As of July 21, we are reporting 165,141 vaccine doses administered in Huron Perth by HPPH and partners.
- For Huron Perth residents aged 12 and over, 76.6% have received one dose of vaccine, and 58% are fully vaccinated.
- HPPH updates Huron-Perth vaccination coverage information on a separate dashboard available at our COVID-19 Data in Huron and Perth page. You can also directly visit the HPPH [COVID-19 Vaccination Coverage Dashboard](#).

## Also remember

- Anyone who has received a first dose, or both doses, of a COVID-19 vaccine must continue to follow all public health measures as described in Reopening Ontario legislation because a significant number of our population must be vaccinated with both doses to provide enough protection. As long as COVID is still circulating in Ontario, it is important to continue public health measures, even if you are vaccinated. Updated provincial guidance for fully vaccinated individuals is pending.

- The Huron Perth COVID-19 Mass Vaccination Advisory Committee (HPMVAC) is a collaborative of multiple relevant sector stakeholder members from our Huron and Perth communities.
- Under the leadership of Huron Perth Public Health, our table has been meeting to inform COVID-19 mass vaccination planning and operations for our communities.
- This memo serves to update you, our community members and partners. Please note, guidance provided is subject to change. This reflects the evolving nature of COVID-19 and related supply chain logistics.
- Note for Partners: Vaccine doses can be maximized through use of 1mL syringes. We ask our healthcare partners to consider using alternate syringe sizes where appropriate to preserve all 1mL syringes for vaccination purposes in our communities.

## APPENDIX A – Individuals eligible for shortened second-dose interval

- Individuals who are 12 or older, and have received their 1st dose of mRNA vaccine.

### **Groups who should receive second dose as close to product monograph as possible:**

- Individuals on Immunosuppressive Therapy - Individuals in the authorized age group who are taking an anti-CD20 agent (e.g., rituximab, ocrelizumab, ofatumumab)
  - Please speak to your healthcare provider first, as they can help you with the best timing for your vaccine given your treatment plan.
- Transplant recipients (including solid organ transplants and hematopoietic stem cell transplants).
- Stable, active treatment for malignant hematologic disorders and non-hematologic solid tumour (excluding individuals receiving solely hormonal therapy or radiation therapy).
- If you have one of the above two medical conditions, please contact your primary care provider.
- Individuals undergoing hemodialysis or peritoneal dialysis
- Individuals with an imminent start date for any of above therapies or treatments.

### For individuals who received AstraZeneca vaccine as first dose

- If you received AstraZeneca as your first dose, you should receive your second vaccine (AZ or an mRNA) 8 -12 weeks later for optimal immune response. (Note the interval related to mRNA 2<sup>nd</sup> doses may change with the availability of supply). Some people, in consultation with their health care provider, may need to book earlier than 8-12 weeks due to their medical treatment schedule.
- Ontarians who received their first dose of the AstraZeneca COVID-19 vaccine can choose to either receive a second dose of the AstraZeneca vaccine, or an mRNA (Pfizer or Moderna) vaccine for their second dose.
  - Both of these options are safe and provide strong protection against COVID-19. In addition, they will count as a completed vaccine series.
  - Both options are at a recommended 8 to 12-week interval except for the following:
    - An individual should talk to their healthcare provider if they have one of the following conditions and an 8 to 12-week interval would affect the timing of their treatment:
      - Individuals on Immunosuppressive Therapy - Individuals in the authorized age group who are taking an anti-CD20 agent (e.g., rituximab, ocrelizumab, ofatumumab)
      - Transplant recipients (including solid organ transplants and hematopoietic stem cell transplants).
      - Stable, active treatment for malignant hematologic disorders and non-hematologic solid tumour (excluding individuals receiving solely hormonal therapy or radiation therapy).
      - Individuals undergoing hemodialysis or peritoneal dialysis
      - Individuals with an imminent start date for any of above therapies or treatments.
