




### A Message from the Medical Officer of Health & CEO




### About Huron Perth Public Health (HPPH)

Huron Perth Public Health (HPPH) was created January 1, 2020, from the amalgamation of the former Huron County Health Unit and Perth District Health Unit.

HPPH serves Huron County, Perth County, the City of Stratford, and the town of St. Marys, providing these communities with public health programs and services that prevent disease and injury, and promote health.

We are governed by the Health Protection and Promotion Act (HPPA) and provide services in accordance with the Ontario Public Health Standards (OPHS).

**Accountability**— We focus on our public health mandate and are committed to transparent accountability for the use of our resources


**Leadership**— All staff are valued as HPPH ambassadors who continually show leadership by using public health knowledge, skills and expertise to improve population health

- We will leverage partnerships to enhance the impact of HPPH's work


- Improved community and partner knowledge and awareness of HPPH

#### To achieve this strategic priority


- We will continue to deliver evidence-informed programs and services in alignment with our mandate

- We will continue our emergency preparedness, leveraging lessons learned, to ensure effective continuity of operations and services


- Stable and planned transitions to align with public health landscape changes in Ontario

Huron Perth Public Health takes action to protect and promote population health and prevent disease, strengthening the quality of life and well-being for all.




#### What this Strategic Priority means for HPPH:
