However, interacting with animals can make people sick if precautions are not taken. To prepare for the event, you are required to:</li> <li>Inform Huron Perth Public Health of any changes to your original application.</li> <li>Post HPPH-provided signs at all entrances and exits to and from all animal areas that remind visitors to wash their hands.</li> <li>Have handwashing stations with soap, water and paper towels at all entrances and exits for all animal areas.</li> <li>Ensure all animals requiring rabies vaccine under <i>Ontario Regulation 567/90: (O. Reg.) Rabies Immunization</i> are up to date.</li> <li>Develop a plan for the prompt removal of manure and soiled bedding to keep the animal enclosures clean.
