

Municipal Liaison Program Report 2024

Program Overview

Working with local municipalities is an essential part of effective public health practice, and collaboration between municipal and public health staff supports positive outcomes in the community. There are 17 municipalities across Huron and Perth counties, including two upper-tier, two single-tier, and 13 lower-tier. In 2024, Huron Perth Public Health (HPPH) adopted a more structured approach to collaborating with municipalities in order to:

Establish or strengthen relationships between municipal and public health staff. Improve understanding of local community context, which informs public health programming.

Increase internal HPPH collaboration to support coordination and reduce duplication. Support municipalities in how they interact with public health.

Actions in 2024

Launch

Launched an internal Municipal Collaboration Network to connect HPPH staff who interact with and provide services to municipalities.

Liaise & Learn

Assigned three Public Health Promoters to act as liaisons. Stayed current in local community context by beginning to review municipal communications.

Collaborate

Initiated alignment meetings to learn about municipal priorities, plans, by-laws, processes and consultations relevant to public health, and to identify collaboration opportunities.

Municipal Alignments

There were 148* municipal alignments in 2024, initiated by municipalities or by HPPH. These alignments encompassed various interactions, from informal discussions and meetings to defined outcomes. While some alignments remain informational, others have sparked larger initiatives and have evolved beyond an initial discussion.

Healthy Public Policy Development

- Submitted feedback to Perth County's and South Huron's Official Plans.
- Participated in community consultations for recreation master plans in West Perth and St. Marys.
- Initiated support for City of Stratford's and County of Huron's Smoking and Vaping By-Law reviews.
- Provided best practice recommendations for North Huron's Municipal Alcohol Policy.



Community & Partner Mobilization

- Co-planned Sustainable Huron's "Healthy Aging in Huron" meeting.
- Assisted North Perth in applying for the Intersectoral Action Fund to support equity and diversity initiatives.
- Identified key municipal staff to inform processes outlining the roles and responsibilities of both municipal staff and HPPH's Environmental Health team specific to community programs and services.
- Amplified local voices in provincial circles on rural transportation issues.




Health Communication

Collaborate

Complete follow-up from actions identified in 2024. Continue to collaborate with municipalities, build relationships, and find synergy within community programs and services.

Liaise & Learn

Extend invitations to remaining municipalities, requesting an alignment meeting. Onboard two additional Municipal Liaisons.

Sustain

Set a calendar that outlines municipality alignment meeting frequency and re-meet with those who will be participating in annual alignment meetings.
